ORDINANCE NO. 2010-311

"AN ORDINANCE TEMPORARILY CLOSING THE LUTIMAN-GUICAM PROVINCIAL ROAD IN THE MUNICIPALITY OF ALICIA, ZAMBOANGA SIBUGAY BY PROHIBITING THE ENTRANCE OF ANY KINDS OF HAULERS, CARGO TRUCKS, PRIVATE DUMP TRUCKS AND OTHER HEAVY AND SIMILAR MOTOR VEHICLES NOT HEREIN CONSIDERED EXEMPT FROM PASSING THROUGH THE SAID ROAD.

EXPLANATORY NOTE

WHEREAS, Art. 43 of R.A. 7160, government grants authority to a local government unit, through an ordinance to temporarily close any road within its jurisdiction;

WHEREAS, temporary closure of any road is reasonable and possible when public work projects are being undertaken for a period as may be determined necessary to facilitate completion of the projects as stated in Art. 45 (3) of R.A. 7160;

WHEREAS, Lutiman-Guicam Provincial Road at Alicia, Zamboanga Sibugay is a provincial road under the jurisdiction of the Local Government Unit of Zamboanga Sibugay Province;

WHEREAS, the said Provincial Road needs immediate and prompt rehabilitation for the best interest of the public and for early completion of the subject rehabilitation, temporary closure of the same is necessary in order not to delay and hamper the undertaking of the subject public works project;

NOW THEREFORE

BE IT ORDAINED by the Sangguniang Panlalawigan of Zamboanga Sibugay, in session assembled:

SANGGUNIANG PANLALAWIGAN SANGGUNIANG PANIALA

Section 1. Title - This ordinance shall be known as “AN ORDINANCE TEMPORARILY CLOSING THE LUTIMAN-GUICAM PROVINCIAL ROAD IN THE MUNICIPALITY OF ALICIA, ZAMBOANGA SIBUGAY BY PROHIBITING THE ENTRANCE OF ANY KINDS OF HAULERS, CARGO TRUCKS, PRIVATE DUMP TRUCKS AND OTHER HEAVY AND SIMILAR MOTOR VEHICLES NOT HEREIN CONSIDERED EXEMPT FROM PASSING THROUGH THE SAID ROAD”.

Section 2. Objective and Purpose – To temporarily prohibit the use and passage of heavy equipment, and all kinds of motor vehicles, whether private and public utility from passing through the said road which is undergoing repair and rehabilitation.

Section 3. Coverage - The foregoing ordinance covers any kinds of heavy equipment and all kinds and types of motor vehicles not herein considered exempted from passing through the aforementioned road in order not to hamper or cause delay in the on-going repair and rehabilitation of the said road.

Section 4. Exempt Vehicles – Motorcycles and other light transport vehicles are exempt from the implementation of the foregoing ordinance provided that their passage and utilization of the said road is allowed by the Provincial Engineer’s Office of the province particularly the person in charge of the repair.

Section 5. Authority of law enforcers - The PNP, the Philippine Army, the Provincial Security Group (PSG), and other recognized and legitimate law enforcement agencies designated by the concerned local government unit are enjoined and commanded to strictly implement the foregoing ordinance.

Section 6. Repealing Clause – All ordinances, resolutions or laws of local application and effect inconsistent hereto are hereby modified, superseded and repealed accordingly.

Section 7. Separability Clause – If, for any reason or reasons, any part or provision hereto shall be held to be constitutional or invalid, other parts or provisions hereof which is not affected thereby shall continue to be in full force and in effect.

Section 8. Duration of Effectivity - This ordinance shall take effect immediately upon approval and shall end upon completion of the subject road rehabilitation.
