**ORDINANCE NO. 2001-009**

**AN ORDINANCE ESTABLISHING MARKERS OR SIGNBOARDS IN THE HIGHWAY, BOUNDARIES, SEAPORT, AIRPORT, AND ALL POINTS OF ENTRY IN THE PROVINCE OF ZAMBOANGA SIBUGAY.**

---

**BE IT ORDAINED** by the Sangguniang Panlalawigan of Zamboanga Sibugay in session assembled:

**Section 1. Title** - This ordinance shall be known and hereinafter referred to as an “ Ordinance establishing markers or signboards in the highway, boundaries, seaport, airport, and all points of entry in the province of Zamboanga Sibugay.”

**Section 2. Nature and description** - The signboards or markers shall be permanent in nature with a dimension of at least three (3) feet by six (6) feet or a total of eighteen (18) square feet, preferably made of concrete structure with the following inscriptions, viz:

Front side:

**“ WELCOME ! YOU ARE NOW ENTERING THE PROVINCE OF ZAMBOANGA SIBUGAY”**

Back portion:

**“ YOU ARE NOW LEAVING THE PROVINCE OF ZAMBOANGA SIBUGAY. DAGHANG SALAMAT! “**

**Section 3. The site/placement** - The markers or signboards shall be permanently placed in the following boundaries, to wit:

- a. Kumalarang, Zamboanga del Sur and Buug, Zamboanga Sibugay;
- b. Tampilisan, Zamboanga del Norte and Titay, Zamboanga Sibugay;
- c. Licomo, Zamboanga City and Tungawan, Zamboanga Sibugay; and

3.4. All significant points of entry (i.e. airport, seaport, etc.).

**Section 4. The Provincial Engineer's Office (PEO)** - The PEO shall be responsible in the implementation of this ordinance and is mandated to complete the project within a reasonable period of time after its approval. The PEO is likewise authorized to charge the corresponding expenses in relation hereof against any available funds of the province.

**Section 5. Separability Clause** - If for any reason or reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**Section 6. Effectivity**- This ordinance shall take effect immediately upon approval.
