AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 2001-003 (ON PERSONNEL SCHEDULE) BY PROVIDING AND CREATING THE POSITION OF INFORMATION OFFICER-IV (SG-22/1) IN THE OFFICE OF THE PROVINCIAL GOVERNOR EFFECTIVE SEPTEMBER 1, 2001, AND PROVIDING FUNDS THEREFOR.

BE IT ORDAINED by the Sangguniang Panlalawigan of Zamboanga Sibugay, in session assembled:

Section 1. Title - This ordinance shall be known and thereafter referred to as "An ordinance amending Ordinance No. 2001-003 (on personnel schedule) of the province of Zamboanga Sibugay by providing and creating an additional position of Information Officer IV with salary grade 22 in the office of the provincial governor effective September 1, 2001, and providing funds therefor."

Section 2. The Information Officer IV - There shall be created an additional position of Information Officer IV under the office of the provincial governor in the province of Zamboanga Sibugay effective September 1, 2001.

Section 3. Source of Funds - The budget allocation for the vacant position of Security Officer IV with salary grade 22 under the office of the provincial governor shall be utilized, by way of effecting immediate transfer of its budgetary allocation or by way of realignment, as the case may be, to fund the aforementioned additional position.

Section 4. Repealing Clause - All ordinances, resolutions or laws of local application and effect inconsistent hereto are hereby modified, superseded, and repealed accordingly.

Section 5. Separability Clause - If, for any reason or reasons, any part or provision hereof shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 6. Effectivity - This ordinance shall take effect immediately upon approval.
