AN ORDINANCE ADOPTING ALL RESOLUTIONS AND ORDINANCES OF THE MOTHER PROVINCE, THE PROVINCE OF ZAMBOANGA DEL SUR, APPLICABLE TO THE PROVINCE OF ZAMBOANGA SIBUGAY UNTIL FURTHER AMMENDMENT THERETO.

BE IT ORDAINED by the Sangguniang Panlalawigan of Zamboanga Sibugay in session assembled:

- Section 1.* - New Province - Needless to say, being a new province, the Province of Zamboanga Sibugay, does not have local resolutions and ordinances of its own for their implementation.
- Section 2.* - Ordinances of the Province of Zamboanga del Sur - Being a part of Zamboanga del Sur before its creation, ordinances duly approved by the Sangguniang Panlalawigan of the mother have been implemented in the area.
- Section 3.* - Adoption of Resolutions and Ordinances - The new government of the Province of Zamboanga Sibugay hereby adopts all resolutions and ordinances applicable to the province such as, but not limited to staffing pattern compositions, & positions powers, duties and responsibilities of its officials and employees, revenues, and/or tax ordinances, and other regulatory ordinances.
- Section 4.* - Implementing Guidelines - The province thru the provincial governor is hereby empowered to review and promulgate the implementing guidelines of these ordinances.
- Section 5.* - Separability Clause - All sections or provisions of this ordinances which may be declared unlawful or unconstitutional shall not affect the other sections or provisions thereof.

Section 6. - Repealing Clause - All ordinances , resolutions or laws of local effect not in consonance hereto are hereby modified, superseded or repealed accordingly.

Section 7. - Effectivity - This ordinance shall take effect upon its approval by the provincial governor and 15 days after its publication in a local newspaper of province wide circulation for three (3) consecutive weeks. For this purpose the amount of P 6,000.00 is hereby appropriated for the payment of publication cost.
