AN ORDINANCE CREATING AN OFFICE TO BE CALLED SUB-CAPITOL OF THE EAST, PROVINCE OF ZAMBOANGA SIBUGAY AND TO BE ESTABLISHED MORE PARTICULARLY AT THE MUNICIPALITY OF IMELDA, THIS PROVINCE.

BE IT ORDAINED by the Sangguniang Panlalawigan of Zamboanga Sibugay, in session assembled:

Section 1. Title - This ordinance shall be known and thereafter referred to as “*Sub-Capitol of the East Ordinance*”.

Section 2. Creation - There shall be, hereby created an office to be called Sub-Capitol of the East, province of the Zamboanga Sibugay and to be established the Municipality of Imelda, this province.

Section 3. Manpower - At the recommendation of the different department heads and with the approval of the Provincial Governor subject to review and concurrence of the Sangguniang Panlalawigan there shall be assigned different personnel in this office whose salaries or wages and other benefits shall be paid by the Province for the more effective delivery of basic services and/or for the effective implementation of revenue raising and other ordinances.

Section 4. Implementing Guidelines - The office of the Provincial Governor with the assistance of the HRMO and other department heads, as the case maybe, shall promulgate the implementing rules and guidelines for this purpose.

Section 5. Responsibility - It shall be the responsibility of the different department heads to monitor the performance and accomplishments of the different personnel under their respective offices and who are assigned in this particular office.

Section 6. Repealing Clause - All ordinances, resolutions or laws of local application and effect inconsistent hereto are hereby modified, superseded, and repealed accordingly.

Section 7. Separability Clause - If, for any reason or reasons, any part or provision hereof shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 8. Effectivity - This ordinance shall take effect immediately upon approval.
