ORDINANCE NO. 2010-325

AN ORDINANCE ESTABLISHING AND CREATING THE ZAMBOANGA SIBUGAY PROVINCIAL ECONOMIC MANAGEMENT COUNCIL (PEMC), DEFINING ITS SCOPE AND COVERAGE, AND PROVIDING FUNDS FOR THE PURPOSE.

WHEREAS, the province is blessed with natural resources consisting of rubber, coal, seaweeds, fishponds, precious metals, and many others;

WHEREAS, the Sangguniang Panlalawigan approved several ordinances establishing and creating different industries for the purposes to oversee and regulate it's sector ;

WHEREAS, it is inherent of the provincial government to plan, develop and implement programs which will increase the income of its citizens and improve the productivity of their labor;

WHEREAS, as means of making a reality the above mentioned, the Provincial Government shall make the most of its natural resources and harness the same into industries that will lift the agricultural and industrial sectors of the province;

WHEREAS, there is a need to converge the local government units and its instrumentalities, the national government and its agencies, other stakeholders and as well as the private sector, in support of the flagship projects of the Provincial Government;

WHEREAS, to realize this end, it is imperative to create an economic development management body that will formulate policies, strategies, implement, monitor, evaluate other related activities thereof;

BE IT ORDAINED by the *Sangguniang Panlalawigan of Zamboanga Sibugay, in session assembled:*

SECTION 1. TITLE. There is hereby created and established the “**Zamboanga Sibugay Provincial Economic Management Council**” under the Office of the Provincial Governor.

SECTION 2. DECLARATION OF POLICY. It is hereby the policy of the Provincial Government to protect, promote, formulate policies, strategies, monitor, evaluate, and implement development activities in order to increase and maximize production of all industry of the province.

SECTION 3. OBJECTIVES - The objectives of the Council are:

- a. To promote and develop all the industries of the Province of Zamboanga Sibugay; and
- b. To develop and formulate local objectives, plans, policies and priorities for the orderly development and the generation of economic activities consistent with the development needs of the province of Zamboanga Sibugay.

SECTION 4. THE ZAMBOANGA SIBUGAY PROVINCIAL ECONOMIC MANAGEMENT COUNCIL – *composition, duties, and functions.* The Council shall be composed of the following: One (1) Chairman, One (1) Co-Chairman and Two (2) Members. All members will be appointed by the Provincial Governor through an Executive Order. Pursuant to this, the Council shall be vested with the following duties and functions:

- a. To manage, and oversee all economic enterprise of the Province of Zamboanga Sibugay, and shall promulgate such rules and regulations, with the approval of the Provincial Governor, as are necessary;
- b. It shall serve as the think-tank of the Provincial Governor and, as such, it shall formulate plans, policies, and strategies to enhance economic opportunities and oversee the implementation of the same through the various instrumentalities of the government;
- c. To establish a provincial database as a source of reference in planning;
- d. To consolidate, organize and interact with various government instrumentalities and the private sector for a unified development direction and goal;
- e. To plan for the development of industries in the province with a focus on, but not limited to, the available natural resources found in the area;

- f. To establish mechanisms designed to regulate the economic and industrial investment in the area;
- g. To recommend to the Provincial Governor necessary measures to streamline all local government instrumentalities and programs that the Council may deem appropriate in the execution of this order to enhance efficiency and eliminate redundancy;
- h. To exercise such other powers and functions as the Provincial Governor may direct; and ;
- i. Periodically report, update, and regularly seek direction from the Provincial Governor to synchronize its efforts with the Provincial Governor's priorities.

SECTION 5. SECRETARIAT. The Provincial Legal Officer shall serve as the Secretariat of the Council and shall be responsible for the documentation of its proceedings and it shall serve as liaison and administrative center of the Zamboanga Sibugay Provincial Economic Management Council.

SECTION 6. HONORARIUM. The Council will fix the amount of honorarium of its members and to any invited resource person to attend its meeting on matters related under deliberation.

SECTION 7. BUDGETARY REQUIREMENTS. In order to have an effective implementation of this ordinance, an annual budgetary requirement of **One MILLION PESOS (Php 1,000,000.00)**, to be taken from 20% Economic Development Fund (EDF) Fiscal Year 2011, is necessary for the operation of the Zamboanga Sibugay Provincial Economic Management Council, for purposes of administrative and operational expenses of the council subject however, to existing Commission on Audit (COA) rules, regulations, and applicable laws.

SECTION 8. SEPARABILITY CLAUSE. If, for any reason or reasons, any provision of this ordinance shall be held to be inconsistent with existing laws, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 9. REPEALING CLAUSE – (a) Except as otherwise provided in the ordinance, the following are repealed; (1). Ordinance Nos. 2009-281, and 2009-282, (2). All ordinances, resolutions or laws of local application and effect which are inconsistent hereto are hereby modified, superseded, and repealed accordingly.

SECTION 10. EFFECTIVITY – This Code shall take effect upon approval by the Provincial Governor.
