## **INVITATION TO BID**

The Provincial Government of Zamboanga Sibugay, through the **ZAMBAS & OTHER ACCOUNT-Trust Fund**, intends to apply the sum of **Php12,638,626.00** being the Approved Budget for the Contract (ABC) to payments under the contract for **Rehab of Water Supply System Level II @ Brgy. Poblacion, Payao, Zamboanga Sibugay**. Bids received in excess of the ABC shall be automatically be rejected at bid opening.

The Provincial Government of Zamboanga Sibugay now invites bidders. Completion of the Works is required 295 working days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Provincial Government of Zamboanga Sibugay and inspect the Bidding Documents at the address given below on January 16 to 23, 2012 from 9:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Php13,000.00.

The Provincial Government of Zamboanga Sibugay will hold a Pre-Bid Conference on **January 24, 2012 @ 1:00 p.m.** at the BAC Conference Room, Capitol Compound, Ipil Heights, Ipil, Zamboanga Sibugay, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **February 7, 2012 @ 12:00 noon** at the BAC Secretariat Office, Ipil Heights, Ipil, Zamboanga Sibugay. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Provincial Government of Zamboanga Sibugay reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
